

# **HORSES**

- Rule 1. Entries in this department will begin at 9:00 a.m. on Saturday, September 10<sup>th</sup>. Horse show will begin at 10:00 a.m. No entries will be accepted after the start of the first class. Proof of a negative Coggins test dated within 12 months of the fair horse show is required for any and all horses entered.
- Rule 2. Stalls will be on a first come first serve basis.
- Rule 3. All animals must be properly groomed for the show.
- Rule 4. No one under 18 years of age will be allowed to show a stallion.
- Rule 5. You must enter the class of your age bracket only.
- Rule 6. An exhibitor may show only one animal per class.
- Rule 7. Age of horse & contestant will be computed as of the day of the horse show.
- Rule 8. Horse show will be held in the Fred Humphrey Pavilion.
- Rule 9. Class order will run as scheduled.
- Rule 10. No one allowed in arena but exhibitors, judge and stewards.
- Rule 11. Horses and exhibitors must be ready for their classes prior to the start of the preceding class.
- Rule 12. The arena and arrangements will be under the direct supervision of the Superintendent of the Horse Department.
- Rule 13. If there are two or less entries in a halter division, that division will not show for Grand or Reserve Champion.
- Rule 14. All decisions made by the judge and/or superintendent are final.
- Rule 15. Negative Coggins Test Required. NO EXCEPTIONS.  
Horses entering the Pott. Co. Fair Horse Show must have a current negative Coggins Certificate dated within 12 months of the fair horse show date. Horses without a current negative Coggins Certificate will not be allowed to show and must leave the grounds immediately.
- Rule 16. Rules set by the Superintendent of Horses and/or judge are final.
- Rule 17. All patterns to be posted at time of show by the judge.
- Rule 18. This is the Pottawatomie County Fair Open Horse Show. Open to all eligible adults and youth who are residents in Pottawatomie County and not limited to only 4-H and FFA members in Pott. County. The 4-H Horse Show Rule Book shall be used only as a guideline of the horse show with the judges' decision being final. Split reins and tie-downs will be at the decision of the judge.
- Rule 19. Exhibitors and Owners must be residents of Pottawatomie County unless otherwise provided by special Rules.
